7. HANDLING AND STORAGE

Precautions for Safe Handling

Appropriate Engineering Controls

Product Disposal:

Product wastes are controlled wastes and should be disposed of in accordance with all applicable local and national regulations. In this specific case the product is a flammable substance and therefore can be sent to an approved high temperature incineration plant for disposal.

Personal protective clothing and equipment as specified in Section 8 of this SDS must be worn during handling and disposal of this product. The ventilation requirements as specified in the same section must also be followed, and the precautions given in Section 7 of this SDS regarding handling must also be followed.
