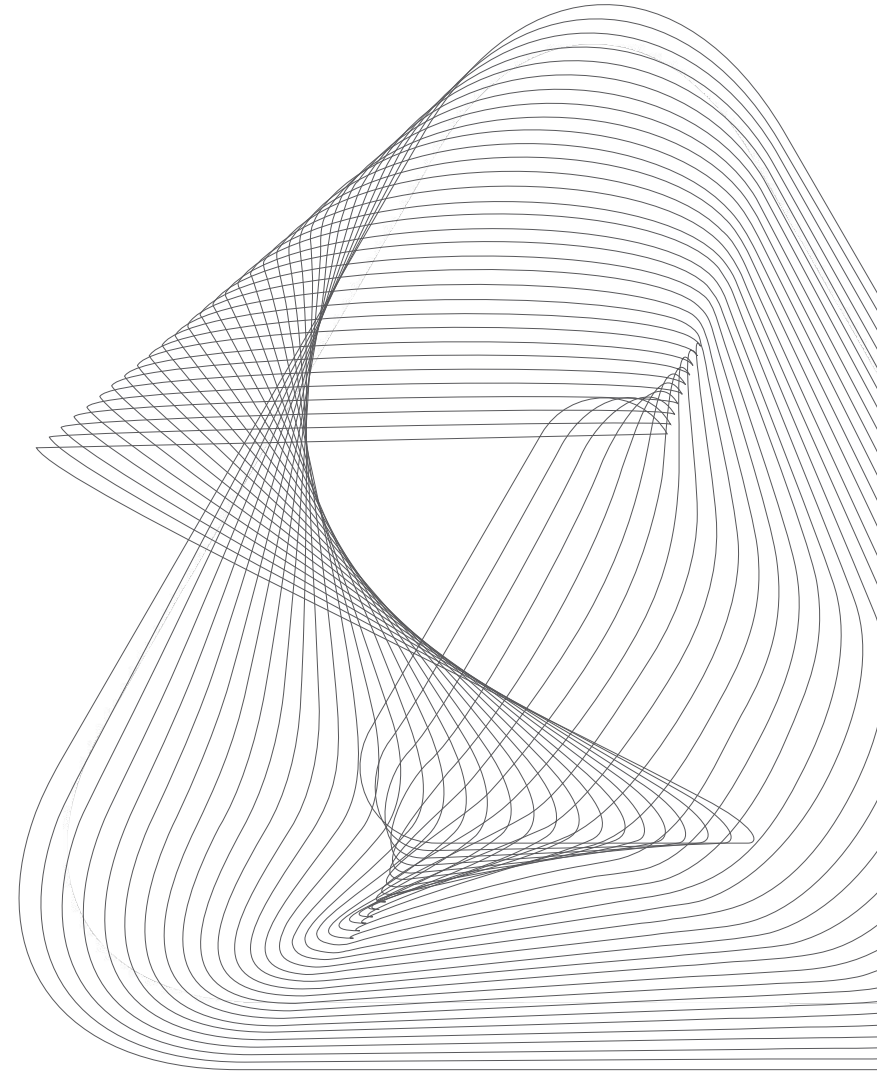

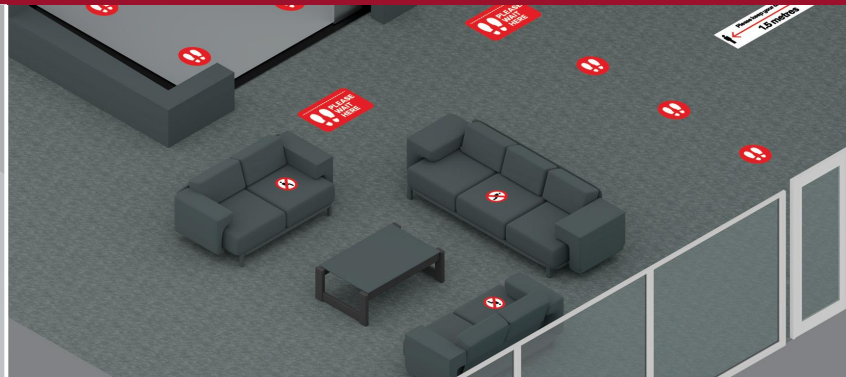
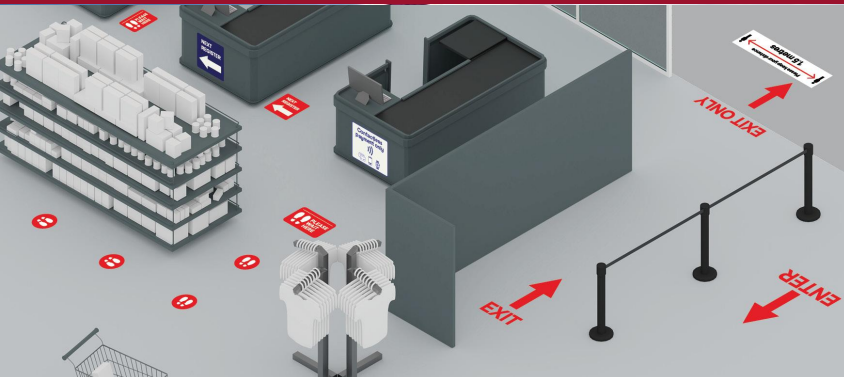

Safety Signage Preferred Locations

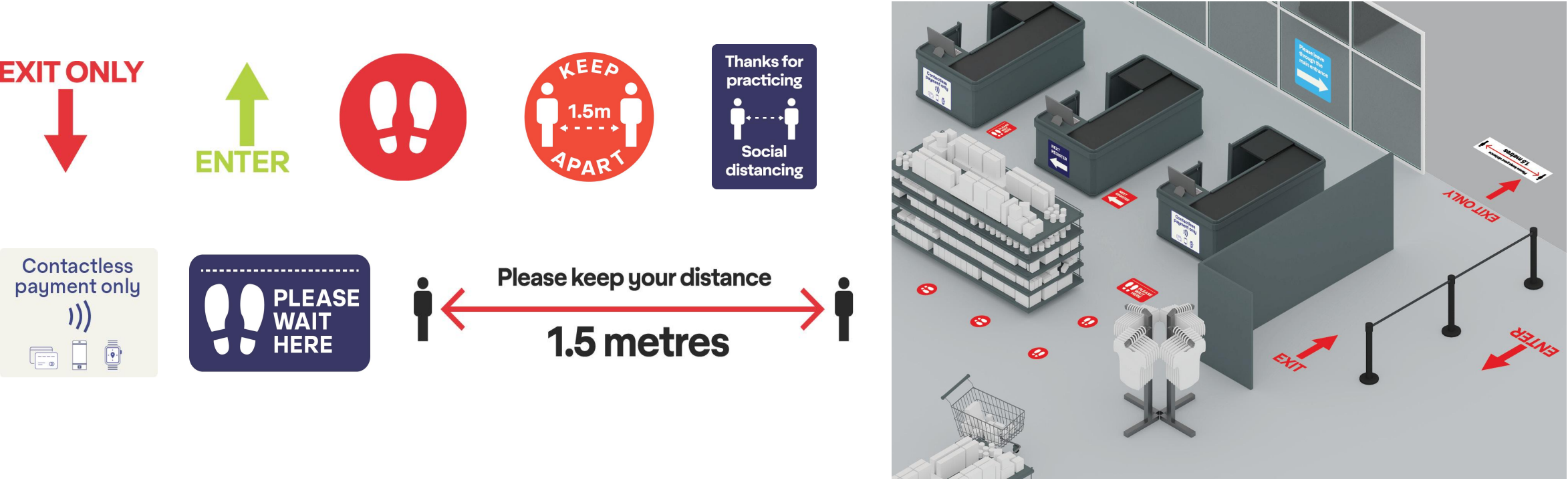


Retail Shops

Retail environments can be tricky with most shops required to track customers coming and going from the store to make sure they don't exceed safe shopping numbers for their shop size. Controlled Enter and Exit signage makes this easier to maintain.

Floor graphics including "Stand Here" feet signs and reminders of the 1.5m rule are also very popular in retail environments to remind customers. Some shops have also stopped handling cash and have moved to a Contactless Payment Only in order to protect staff.

Restaurants and Cafes

Restaurants and Cafes have been hit hard by Covid-19 safety procedures, a lot of restaurants had to close their doors completely while we flattened the curve.

With restrictions now easing most Restaurants and Cafes are now open but need to follow very strict rules regarding how many patrons are allowed inside at any one time and if they are allowed to sit and eat or not.

Healthcare

Healthcare facilities have been inundated with people who have symptoms, might have Covid-19 and need to be tested quickly. Until they are diagnosed they could be carrying Covid-19 and safety steps must be taken.

Hospital and Healthcare facilities have shared services and waiting rooms, the correct safety signage in these locations is extremely important.

Typical requirements for Covid-19 Safety Signage in a Hospital or Healthcare environment.

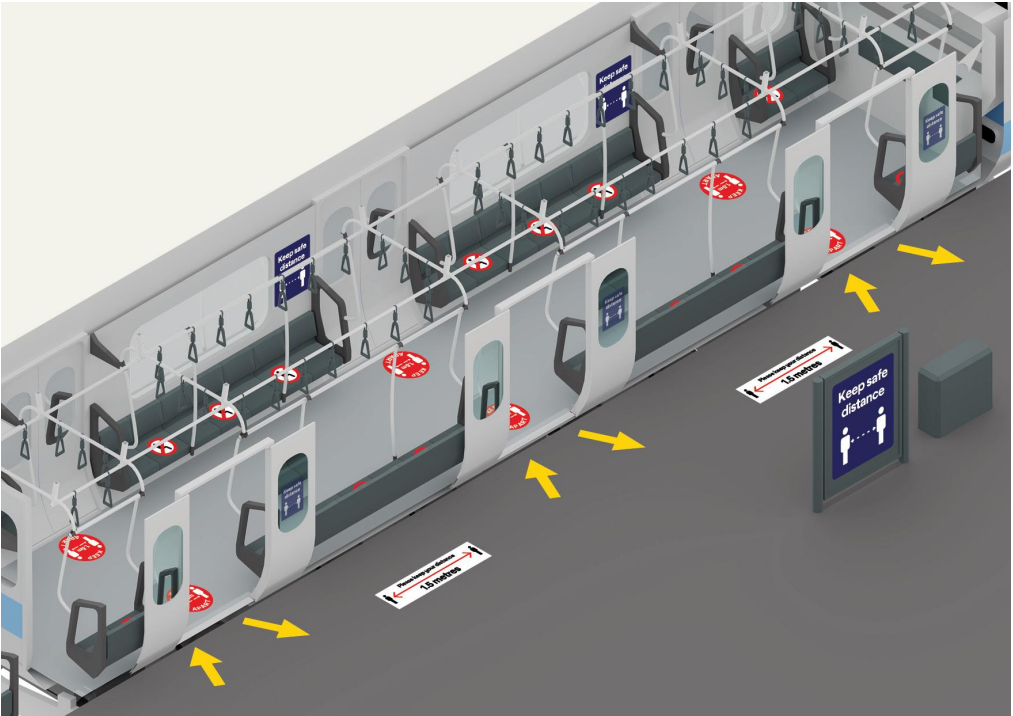


Public Transport

Typical requirements for Covid-19 Safety Signage on Public Transport.

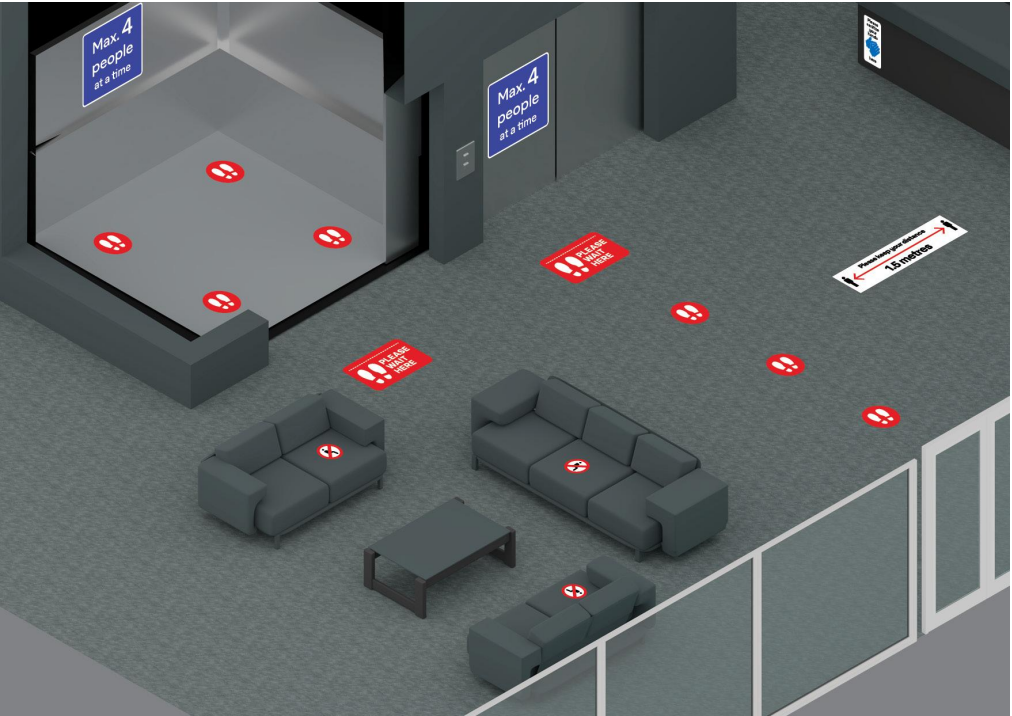


Commercial

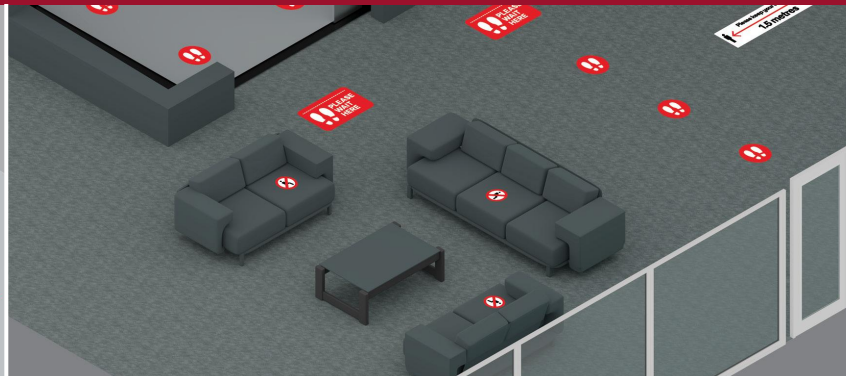
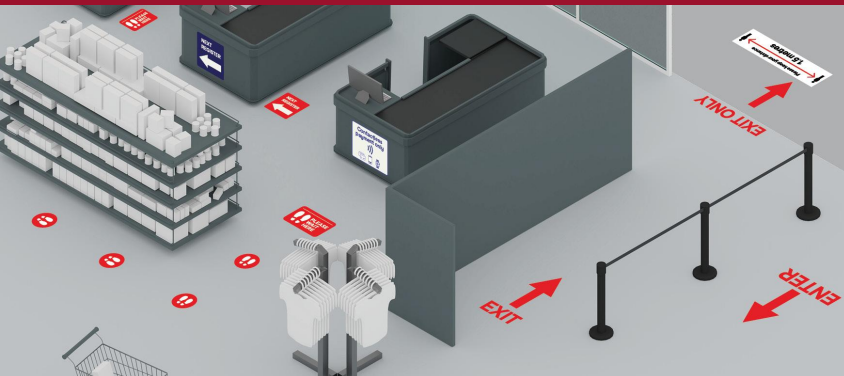
Commercial spaces can include all types of buildings and locations from Small Offices to Large Warehousing Facilities. The requirement for Covid-19 Safety Signage in these locations can be just as diverse as the types of locations are from each other.

More unique and one-off signs may also be required e.g. Staff Lunch Room Capacity. Below is some of the more common required signs but make sure to ask about the company's specific Covid-19 Safety Plan.

Anti Graffiti Laminate

The same functionality that allows Anti Graffiti films to be cleaned easily is also why it is a great option for Covid Safety Signs.

Avery Dennison DOL 4300 is a specialised overlaminate that can be cleaned directly with most cleaning agents including disinfectants without being effected, this makes it a great choice for high foot traffic areas that need to be constantly cleaned to stay safe. DOL 4300 is a high clarity product and is rated for both internal and external signage. It has a 5 year expected outdoor durability.

Covid-19 has a surface life on PVC substrates of up to 5 days, signage should be cleaned regularly to stay safe.

Uses

Avery Dennison DOL4300 is a high quality UV stable high gloss anti graffiti polyester overlaminate designed for use as a protective overlamination film for digitally printed images and is suitable for short term indoor or outdoor images on flat surfaces.

Note

PVC / Polyester film combinations are not compatible with acrylic, polycarbonate and other substrates that have a tendency to outgas. Application to these substrates should be avoided as bubbling or blistering can occur due to the inability of Polyester to allow transmission of gas generated by these substrates.

Cleaning of PVC Laminates

Avery Dennison films should not be cleaned or washed within the first 48 hours after application.

For cleaning of exterior floor graphics, the high-pressure equipment should not exceed 1200 psi (80 bars or 84 kg/cm²). A minimum distance of 30cm should be maintained to prevent decal edge lift.

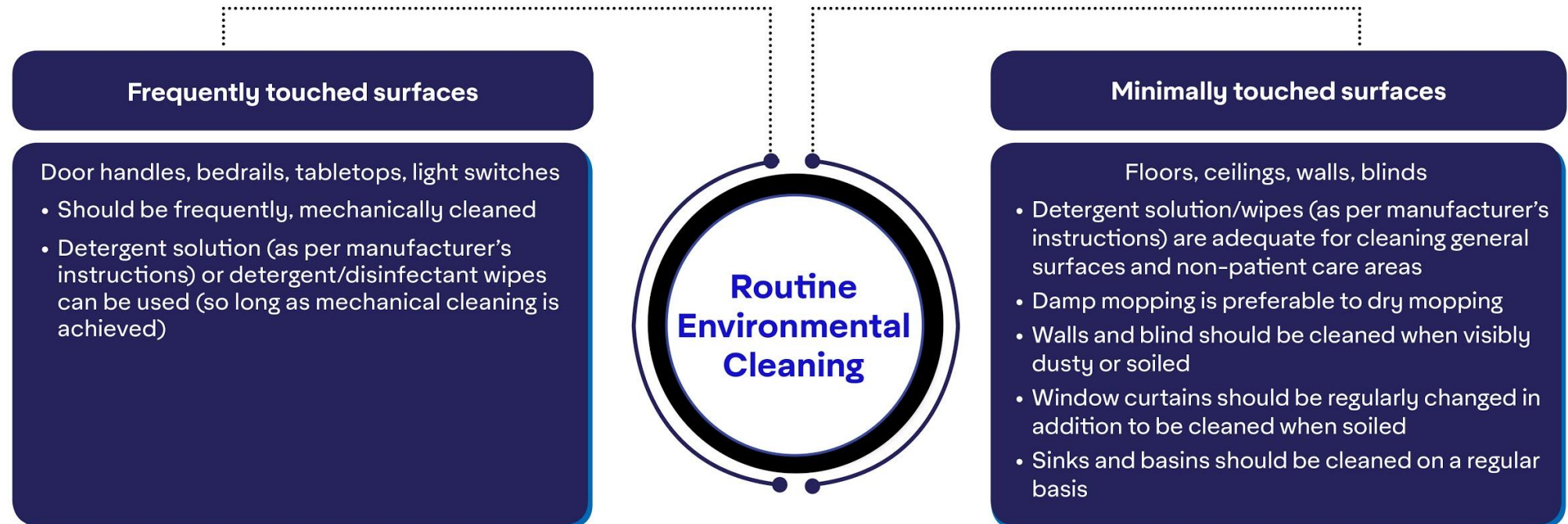
