"I realized there was a huge demand for this type of signage.
So even though it was a really scary time, I decided to change direction." Alex split the vape business with his partners.
Then he sold most of his share of the shops to another vape shop owner and closed the others as their leases ended.
Then he invested in some printing and production equipment.

"Once you get the CWI, you just gain that confidence," says Alex. "And then you just want to keep jumping into using new and different materials." He continues: "I also took an advanced Avery Dennison training course in Atlanta. It was one of the best classes I've taken for learning about color change. Learning those techniques has just given me even more confidence."
